## **CLUB NEWS**

### **District 1**

**Southern Mid Coast Women's Club**, after breaking for January and February, is working to put together a Craft Fair in October. They would love to have other clubs join them to sell things and every one raises some funds. More information in a future issue.

They are also doing a bottle drive to benefit Newborns In Need in March.

**Westbrook Woman's Club** held a silent auction at their annual Christmas party and members donated money received to the

recruiting new GFWC Newtown, CT Woman's Club to help with their efforts to raise funds for the Sandy Hook Elementary School victims.

At the first meeting in January, District 1 President Sally Manchester spoke to members about ovarian cancer. She distributed informative booklets provided by the CDC entitled, "Inside Knowledge", This is a new GFWC partnership, detailing all gynecologic cancers. Perhaps Sally's most important message was if you have a concern - don't wait - speak to your doctor.

Their January 22 meeting was three-fold. Members enjoyed a power point presentation with pictures of birds often seen in southern Maine. These photos were taken by the speaker. She had incorporated the sounds of many of the birds into her presentation. Next on the program was the impressive young woman from Westbrook High School who had attended Dirigo Girls State. She spoke to them in great detail about her experiences there. Judith Reidman, their Parliamentarian, who is a board member for the Family Crisis Services in the Greater Portland area, spoke to the club about the great need for socks for women and children. Their Community Outreach Chairman surprised her by presenting her with 144 pairs of socks they had been collecting for the shelter.

Members enjoyed a mid-winter luncheon in February at the local Fireside Inn. They were entertained by Roger Griswold, Channel 8 Meteorologist, who

spoke about Weather Folklore. At the second meeting in February, they received an update about the success of the Recycling program in Westbrook.

**The 21 Club** started out their new year with a very interesting presentation on the Titanic. It was given by Patricia Turner who has been a Titanic buff for many years. Also at this meeting, they voted to donate to the Sacopec Valley Health Center's dental expansion program.

The Community Improvement Committee presented their plan for a beautification project in Kezar Falls. With Valentine's Day around the corner they gathered Valentine's cards to be brought to the Maine Veteran's Home in Scarborough to brighten their day.

Their February meeting, a potluck, is the perfect way to chase away the winter blahs. For many years this has also been the meeting when they hold a 'shower' for the Ronald McDonald House in Portland. Their club women's generosity is evident in the pile of paper towels, detergent and personal care items collected.

The first meeting in March will be open to the public. Two of their club members will do a program called "Theater Curtains - The Art of Marion Fracher". The presentation will be at the Porter Town Hall where one of these old theater curtains still hangs.

The Gorham Woman's Club had an informative meeting with author and end of life tour guide, Lenora Trussell, RN. Lenora spoke on ways to maintain our

memory as we age. She said it was very important to keep your mind active and interacting with people will help to keep the mind active - volunteering is good! The group learned every time a person smiles it stimulates the brain and exercising and eating well were factors in maintaining a healthy mind. Lenora's final message was to talk to your family about what you want while you are still able. The February meeting continued the same healthy theme with Anne LaPierre, a nutritionist from Hannaford stores. Anne said the key to healthy eating is to be mindful; when reading a food label, the most important thing to check is the serving size; the less processed the healthier the choice; and the body needs good fat (mono-unsaturated).

In January, the club met at the Margaret Chase Library with guest speaker, David Richards, the Director of the Library, who spoke in great detail about Milton Bradley, "the man who taught Americans to play." For February, we met at the Skowhegan Recreation Center where Denise LeBlanc, Skowhegan Recreation Director, gave an overview of current and future plans for Skowhegan recreation opportunities including the ongoing Run of River Project. It's a great facility and provides many wonderful things for our community. On March 1 in honor of Dr. Seuss' birthday, several club members will read *The Lorax*, a Dr. Seuss book, to the 1<sup>st</sup> graders in Skowhegan and Norridgewock. We wear big red and white hats and have a great time. The books are then donated to the classroom libraries. The club is busy planning a "Luck of the Draw" Auction on March 23. This is a major fundraiser for the club and provides scholarship money for qualified, graduating seniors. We gather items from local businesses and from club members for this event and sell hot and cold food, and home-baked goodies and give a wonderful door prize.

GFWC Skowhegan Woman's Club. January 2013, a time to wrap up loose ends from the past and start anew. We added up those volunteer hours, wrote the reports, looked at our

As a member of the Somerset County Animal Response Team and Pet Preparedness in an Emergency, Julie discussed how to prepare for evacuation or care of our pets in an emergency and gave us examples we could all relate to, but not thought much about. Who would feed your pet or give them needed medicine if something happened and you could not get home? Do you have an emergency kit packed with veterinary records in case your pet had to be moved elsewhere in an emergency? Julie covered all these topics and more. Many of our members have pets and she certainly gave us plenty to think about, but also solutions. At our February meeting, Linda Williams spoke to the club about Hospice Care, the need for volunteers and the services that are provided. Hospice not only provides care for those facing death, but also provides help for the caregivers and bereavement follow-up. Hospice can provide much needed information on the services and assistance available. We all felt the information received was most helpful. The newly formed committee for the Skowhegan Interfaith Preschool Daycare Center reported that the churches

were enthusiastic about the endeavor which is a result of a speaker we had in September from Educare. The SWC women heard the need and responded by setting up a meeting with area clergy. It only made sense to involve the churches because that is where facilities are unused and available most weekdays. The speaker from Educare spoke with the clergy at the joint meeting. Raffle tickets were passed out for our FAB Fair Raffle. Each year we raffle off a large number of items to help raise money for scholarships. This year we have over 20 items being raffled including many gift certificates, jewelry, stained glass, and the beautiful afghan Fran Savage makes every year. The members also voted to purchase the General Liability Insurance from AH&T after looking into obtaining this coverage from other companies. The club is going to try a few new things in 2013, we hope to report our volunteer hours in a book at each meeting and we also will have the vice-president keep us up to date on GFWC News and Notes and legislation GFWC feels is important.

**PROPOSED AMENDMENTS TO GFWC MAINE BYLAWS IN 2013**

The following are proposed revisions to be presented for consideration at the 2013 Spring Convention in So. Portland, Maine.

**Item 1.)**

**ARTICLE II - OBJECT**

GFWC Maine shall be operated for charitable purposes as defined by Section 501(c) (3) of the Internal Revenue Code. Its object shall be to bring together the various women's ~~literary and educational~~ clubs of the state for mutual benefit and helpfulness to others.

Strike out "literary and educational" and insert "federated."

IF AMENDED, WOULD READ -

**ARTICLE II - OBJECT**

GFWC Maine shall be operated for charitable purposes as defined by Section 501(c) (3) of the Internal Revenue Code. Its object shall be to bring together the various federated women's clubs of the state for mutual benefit and helpfulness to others.

**Rationale:**

To clarify. As a charitable non-profit group, (with the good fortune to be under the umbrella of GFWC's tax exempt status), also noting that IRS is getting stricter all the time, this will position us to remain in that standing. It also better describes us as a service/volunteer organization. By inserting the word "federated" we clearly state that we are a membership of federated women's clubs, as opposed to various women's clubs that are not, (for example, the ABC Quilt Group of Mytown, Maine.)

**Item 2.)**

**ARTICLE VI - EXECUTIVE ~~BOARD~~**

The Executive ~~Board~~ shall conduct all necessary business of the State Federation during the interim between meetings, except amending the bylaws or modifying any action of the Federation.

Strike out "Board" and change to "Committee."

IF AMENDED, WOULD READ -

**ARTICLE VI - EXECUTIVE COMMITTEE**

The Executive Committee shall conduct all necessary business of the State Federation during the interim between meetings, except amending the bylaws or modifying any action of the Federation.

**Rationale:**

To clarify. Since changing the terminology of “Advisory Committee” to “Board of Directors” in 2011, there has been confusion when saying “the Board.” This would be clearer. Executive Committee means the executive officers, and Board of Directors is the full board, which includes “GFWC Maine Executive Committee (state officers), Club Presidents, District Presidents, Program Chairmen, Committee Chairmen, and Past State Presidents.” as stated in ARTICLE VII – BOARD OF DIRECTORS.

If approved, “Executive Committee” would be placed throughout the bylaws, replacing all mentions of “Executive Board.”

**Item 3.)**

**ARTICLE IX – COMMUNITY SERVICE PROGRAMS/STANDING & SPECIAL COMMITTEES**

~~Section 4. There shall be a HISTORIAN who shall collect and have custody of all State Federation Directories, Club histories, State Spring Convention (Annual Meeting) programs, Fall Conference programs, and files of the Federation Newsletter (Pine Tree Notes) and such records as the Executive Board shall require. She shall give her successor an itemized statement of all properties held by her. She may give an annual report to the Annual Meeting.~~

Strike out the entire section and reword:

**Section 4.** There shall be a **HISTORIAN** whose responsibility is to file the collection of important papers at the end of an administration. These will be placed in the Special Collections Room at the University of Maine in Orono. This will include the Directories, Club histories, State Spring Convention (Annual Meeting) programs, Fall Conference programs, and files of the Federation Newsletter (Pine Tree Notes) and such records as the Executive Board shall require. She may give an annual report at the Annual Meeting.

**Rationale:**

To clarify and update. This is more in line with the current practice and gives much better guidance.

IF AMENDED, WOULD READ as printed above.

If ARTICLE IX – COMMUNITY SERVICE PROGRAMS/STANDING & SPECIAL COMMITTEES Section 4 is revised, we will need to revise duties of Recording Secretary and Corresponding Secretary.

**ARTICLE V - DUTIES OF OFFICERS**

**Section 4:** The Recording Secretary:

- a. The Recording Secretary shall keep the minutes of all meetings of the State Federation and of the Executive Board and Board of Directors.
- ~~b. Once a record book is completed, it will be filed in the Special Collections Room, University of Maine in Orono. Other records, such as awards, may also be filed in this room so long as it is satisfactory with the University and the Executive Board of GFWC Maine.~~

Strike out Section 4b. and reword:

b. Once a record book is completed for the 2-year administration, the Recording Secretary will give the records to the Immediate Past President, who subsequently will review the records before passing them on to the Historian. The Historian has the duty to then file the records in the Special Collections Room, University of Maine in Orono. Other records, such as awards, may also be filed in this room so long as it is satisfactory with the University and the Executive Board of GFWC Maine.

**Rationale:**

To clarify and update. This is more in line with the current practice and gives much better guidance.

IF AMENDED, WOULD READ as printed above.

**Item 5.)**

**ARTICLE V - DUTIES OF OFFICERS**

**Section 5:** The Corresponding Secretary:

- a. The Corresponding Secretary shall conduct all correspondence of the State Federation, as directed, and shall keep a correct list of all clubs belonging thereto.
- b. The Corresponding Secretary shall collect all data for the Directory and furnish typewritten or digital copy of same to the printer. It shall be her duty to edit the Directory, but it shall be the duty of the incoming administration to compile the Directory at the beginning of its term of office.

Add a new c.

IF AMENDED, WOULD READ -

- c. The Corresponding Secretary shall collect and have custody of all State Federation Directories, State Spring Convention (Annual Meeting) programs, Fall Conference programs, and files of the Federation Newsletter (Pine Tree Notes; at the end of the administration she shall give them to the immediate Past President for her review.

**Rationale:**

This is the current practice which was established during the 2010-2012 Administration. The Corresponding Secretary is the one whose duty it is to create these documents, therefore, she can be sure to save the extra copies that will end up in the archives. The immediate Past President will surrender the complete package of records to the Historian for her to deposit at the University.

**Item 6.)**

**ARTICLE IX – COMMUNITY SERVICE PROGRAMS/STANDING & SPECIAL COMMITTEES  
STANDING COMMITTEES**

**Section 2.** There shall be an **ENDOWMENT FUND COMMITTEE** of three (3) members whose duties shall be to further awareness of the purpose of the Fund. The interest accrued from funds raised through the promotion of sales items and from endowments and from donations by clubs, provides GFWC Maine with operating funds. (See Endowment Fund History in GFWC Maine Directory).

Add the sentence:

In the event the interest generated is less than 3% in any given fiscal year, the Executive Committee may withdraw from the fund up to its total of 3% per annum in order to maintain sufficient operating funds for the organization.

IF AMENDED, WOULD READ -

**ARTICLE IX – COMMUNITY SERVICE PROGRAMS/STANDING & SPECIAL COMMITTEES  
STANDING COMMITTEES**

**Section 2.** There shall be an **ENDOWMENT FUND COMMITTEE** of three (3) members whose duties shall be to further awareness of the purpose of the Fund. The interest accrued from funds raised through the promotion of sales items and from endowments and from donations by clubs, provides GFWC Maine with operating funds. In the event the interest generated is less than 3% in any given fiscal year, the Executive Committee may withdraw from the fund up to its total of 3% per annum in order to maintain sufficient operating funds for the organization. (See Endowment Fund History in GFWC Maine Directory).

**Rationale:**

This will protect the Endowment Fund while at the same time help the organization to operate during a difficult economic time.
