In the depression of the 1860's, he began to create games; the most famous one was the "Game of Life". He also created a box of games that could be sent to soldiers during the Civil War. At that time, it was believed that games should be educational and promote virtuous morals. The original Game of Life was created in 1860, with many more versions created through the years, including a centennial version and celebration in 1960. Milton Bradley should be remembered for his beliefs in "thrift, sobriety, and hard work", and that "life is about overcoming failure".

In February, the guest speakers were Marjorie Goodwin and Nancy Ames, on "Heart Health". Other guests were Maureen Provencal from Semper Fidelis and Lynette King from The Dove Society. Nancy Ames spoke about her stroke and an amazing recovery. Marjorie Goodwin spoke the warning signs of heart attacks, what to do, and how to work to improve each person's "Heart Health. # GFWC Maine

## (Who We Are)

In 1868, Mrs. Jane Cunningham Crowley, a newspaper woman in New York City, writing under the name of “Jennie June,” wanted to attend a banquet to honor Charles Dickens. Mrs. Crowley was denied entrance because she was a woman. She felt it was unfortunate men could participate in such interesting and cultural experiences, but not women. She founded the *Sorosis Club*, which was for women only to “represent the active interests of women, and create a bond of friendship between them.”

A few years later, women’s club members from all over the country were invited to meet in New York City, where on April 24, 1890, the first president of GFWC (General Federation of Women's Clubs) stated, “We look for unity, but unity in diversity.”

The GFWC is one of the world’s largest and oldest women’s service organizations. Working locally through thousands of clubs in the U.S. and globally in more than 20 countries, GFWC members support the arts, preserve natural resources, promote education, encourage healthy lifestyles, stress civic involvement and work toward peace and understanding.

In June of 1892, Maine formed a state federation and in 1894 GFWC Maine became the second state to become affiliated with the GFWC. We have two charter clubs still in existence, the GFWC/Skowhegan Woman’s Club and the GFWC/Dexter Women’s Literary Club, both of which are part of District 3. The 24 clubs in the state are spread from Patten to Westbrook and Lubec to Kezar Falls. These clubs are divided into four districts with approximately 650 members in the State.

In its early years, GFWC Maine was influential in promoting the passage of legislation establishing State Traveling Libraries and the passage of an appropriation to develop a Forestry Department at the University of Maine. In 1910-1911, its clubwomen worked for AND against Women’s Suffrage. In 1911 they worked hard for the passage of the Child Labor Law in Maine. During World War I, they devoted many hours to the Red Cross. During World War II, much time and effort went into raising funds for the “Bomber Drive”. More recently, Clubs have joined together in support of such worthy causes as: Camp Kieve in Nobleboro, a science camp for girls, raising funds to publish the “Maine Breast Cancer Resource Guide”, making the book “Believing in Achieving” available to every school in Maine, supporting the Maine Youth Leadership program, raising funds to raise awareness of domestic abuse and violence and make programs available for alcohol and substance abuse. During the 2004-2006 GFWC Maine Administration, the President’s Special Project was “Go Red for Healthy Hearts in Maine”. We joined with the American Heart Association to raise awareness and provide educational materials to Maine women about cardiovascular disease risks, prevention and treatment. During the 2006-2008 Administration, we were involved in the “Maine Women’s Fund”. This is a non-profit foundation that provides women-led organizations with the abilities to empower Maine women and girls to create lasting change so they may reach their full potential and emerge as

confident leaders. In the 2008-2010 GFWC Maine Administration, we were very much involved with “The Food Pantry – Partnering with the Good Shepherd Food Bank. During the 2010-2012 term, we actively participating in the efforts of “Operation Smile” by donating monies and supplying this mission with much needed necessities. We changed the lives of thirteen children and their families by paying for the repair of their cleft lips and palates. In this current 2012-2014 Administration, we are supporting Newborns In Need, a non-profit charity that donates essential baby care items to hospitals, homeless shelters, family crisis centers, county health units, police offices and other organizations that provide for the needs of premature and newborn babies that are sick or in crisis.

The GFWC Maine’s many fields of work are incorporated in six community service programs: Art, Conservation, Education, Home Life, International Outreach, and Public Issues which conform with GFWC. Special Committees within the programs cover major aspects of today’s living.

The GFWC Signature Project: “Domestic Violence Awareness and Prevention” premiered with the 2010-2012 Administration. We are proud to stand behind this project.

We, the clubwomen of GFWC Maine, continue to perform outstanding service in Community Improvement, supporting our local libraries and providing thousands of dollars for scholarships. We seek to unite and strengthen the effect of community service work through volunteerism at home and throughout the world.
